



- c. The Author of the Trust being desirous of establishing the trust hereby transfers a sum of Rs.10,000/- (Rupees Ten thousand only) to the Trust irrevocably and the receipt of which the trust hereby acknowledges. The said sum of Rs.10,000/- shall form the nucleus of the Trust.
- d. In these presents unless the context otherwise requires:
 - i. The Trust shall mean "VICTORIA EDUCATIONAL TRUST"
 - ii. The Trustees shall mean any or all the Trustees as are appointed hereunder and include any other Trustees for the time being.
 - iii. The Trust Property shall mean the nucleus of the Trust, moneys, donations, grants, received within or outside the country, securities and other assets whether obtained by way of the purchase or otherwise and include any other accruals thereto howsoever arising.
 - iv. Objects of the Trust shall mean any or all the objects set out in clause 12 hereof;
 - v. Words imputing the singular shall include the plural and vice - versa.

3. NATURE OF THE TRUST:

3.1. The trust shall be regular having commercial or profit motive what so ever. The properties, securities, moneys and income thereof shall be applied in India solely for the purposes of the trust without any discrimination of religion, region, language, race, caste or sex and no portion thereof shall be distributed among the trustees.

3.2. The affairs of the Trust shall be carried on and managed by the Trustees who shall, for this purpose, exercise all such powers and authority as are necessary for proper achievement of the furtherance of the objects of the trust, notwithstanding that these presents do not expressly provide for the exercise of any such power and authority.

4. NUMBER OF TRUSTEES:

4.1. The number of Trustees including the Author of the Trustees shall not be less than 2 and not more than 7 persons. The Board of Trustees shall nominate and invite person/persons to be the other trustees for such period, as they may deem fit and proper.

5. TERM OF OFFICE OF THE TRUSTEES:



These Trustees shall hold office for such duration as may be specified by the board of trustees.

6.2. The Board of Trustees shall appoint any one or more to the office of Vice President, Vice Chairman, Treasurer and secretary of the Trust and entrust with such rights and powers in relation to the conduct of the Trust and its affairs as needed.

6.3. The Board of Trustees may frame rules and bye-laws for the management of the Trust, its institutions, projects and properties as also the proceedings of the trustees and amend or rescind them as it deems fit from time to time. The rules and bye -laws so framed by the Board of Trustees shall not cause any hindrance to the objects of the Trust and also shall not be opposed to any public law or policies of the Government, for the time being in force.

PRESIDENT:

There shall be a president for the administration of this trust, nominated by the board of Trustees, who shall be one amongst trustees as specified in para (4) above for such period, in such manner as may be specified in this behalf.

7. VACANCIES:

Any vacancy among the Members of the Board of Trustees may be filled by the trustees as specified in clause 4 above or their successors and they shall hold office for such duration as may be specified by the Board of Trustees.

8. VOTING:

Decisions of the Board of Trustees may be made at a meeting or by circulation of papers to them. Normal matters of routine nature may be circulated and decision obtained. The important matters are to be decided at the meeting. All matters arising for disposal shall be decided by a majority of the Board of Trustees present at the Meeting. The President of the Board of Trustees shall have a casting vote in the event of equality of votes, in addition to his own.

10. TERMINATION OF OFFICE OF THE TRUSTEES:

- (a) Trustee shall cease to hold office:
- if he dies,
 - if he resigns,
 - if he is adjudged insolvent or found guilty of an offence involving moral turpitude.
 - if he is found to have acted against the interest of the Trust.
 - if it is unanimously decided by the Trustees specified in para 4 above that his continuation in the Office is against the interest of the Trust.
 - Upon expiry of the period up to which the Board of trustees have nominated the trustee.

11. OBJECTS OF THE TRUST:

- 11.1. To establish Schools, Colleges, Technical and Medical institutions at suitable places in India and device a method to manage them as per the long-term plan devised by the trustees.
- 11.2. To establish, run and maintain educational institutions of formal and non-formal, industrial training, elementary Schools and orphanage and it is the desire of the author that such institutions shall be under the name and style "Unique Tots Montessori" and also under any other names as decided by the trustees in writing.
- 11.3. To organise workshops on education, teaching, language, personality development, building a healthy cultured society, and such other topics.

- 11.4. To co-operate with other official and non-official institutions with similar objectives in all the activities,
- 11.5. To carry out any other useful works incidental or connected with the objects of the trust.
- 11.6. To bring, publish and sell, distribute books, periodicals, leaflets, brochures and papers and also to open and maintain libraries, reading rooms for the promotion of the objects of the Trust.

12. POWERS AND DUTIES OF TRUSTEES:

Without prejudice to the generality of the foregoing provisions, the Trustees shall have and may exercise all or any of the following powers.

- 12.1. To grant fellowship, scholarship or other monetary assistance, on such terms and conditions as they may be prescribed, to such persons as they may select for their overall development.
- 12.2. To prescribe from time to time eligibility for admissions to the institutions run by the Trust, to prescribe the age of persons eligible for admission, the terms and conditions on which the persons may be so admitted, and all other matters relating to the running of the institutions, scholarships, grants, stipends and also to vary all such conditions from time to time.
- 12.3. To decide from time to time, the works to be undertaken in fulfilling the objects of the trust;
- 12.4. To acquire by gift, purchase, exchange, lease or otherwise, lands, buildings or other immovable property together with all rights, appurtenant thereto;

12.16. To appoint, terminate, dismiss, suspend and otherwise deal with the employees of the Trust and its institutions.

12.17. To make donations or contribution or otherwise apply the Trust Funds towards objects of the trust.

12.18. To institute, prosecute and to defend all suits, legal and other proceedings,

12.19. To appear and act before courts, Tribunals, Governmental Tax and other authorities.

12.20. To carry on any other activities which are not detrimental to the objects of the Trust, specifically not traversed herein above.

13. ADMISSION OF TRUSTEES, MEMBERS ETC.:

13.1. The Board of Trustees in their absolute discretion can decide to admit any person as Trustee.

13.2. On any matter concerning the admission of Trustees, the author's decision will be considered as final and binding.

14. RESIGNATION / CESSATION / DIS- QUALIFICATION OF TRUSTEES:

14.1. Any trustee may resign his office by a letter addressed to the Chairman/ Managing Trustee under his hand. The resignation shall take effect from the time the resignation is accepted by the board.

14.2. A Trustee shall cease to be Trustee of the board

14.3. When a trustee becomes subject to any one of the disqualification referred to above and ceases to be a Trustee , it shall be competent to the board to appoint another trustee to their office for such period till the date of re-election;

14.4. The Trustees who are appointed in the place of the other Trustees shall be entitled to participate in the meeting of the board of Trustees and in the activities of the trust and vote and it shall be deemed that the properties of the trust vest in such substituted trustee along with existing trustees;

15. MEETINGS OF THE TRUSTEES:

15.1. The Trustees may meet together for the dispatch of any business, adjourn or otherwise regulate their meetings and proceedings as they may think fit.

15.2. There shall be a quorum when two Trustees are present at any meeting. No business shall be transacted at any meeting of the Trustees, whether ordinary or special, unless the requisite quorum is present thereat.

15.3. Any member of the Board unable to attend the board on any ground whatsoever the resolution passed in his absence shall be binding on him.

16. BOOKS OF ACCOUNTS:

16.1. The accounts of the Trust shall be made for each financial year. The Trustees shall cause true accounts to be kept in such manner as they think fit of all the receipts, credits, payments, assets and liabilities of the Trust. Such books and all vouchers relating thereto and all the documents belonging to the trust shall be kept at such place or places and at the control of officer or officers as the chairman shall from time to time appoint and subject to any restriction as to the time and manner of inspecting the same which may be imposed by the trustees, the same shall be open to the inspection of the Trustees.

16.2. The Trustees shall maintain a true and correct record of the receipts, payments incomes and expenses and transactions of the Trust. The Books of Account of the trust shall be audited by a qualified auditor or a Chartered Accountant every year i.e., commencing from 1st April to the 31st March of next year.

16.3. The accounts shall be submitted for audit within three months from the close of the accounting year and the audited accounts and the report of the Auditor shall be placed before a meeting of the Board of Trustees called specifically for the consideration of such accounts and reports.

17. PROPERTY AND FINANCE:

17.1. The income of the trust derived from any source whatsoever other than from a specified endowment shall be used exclusively for attaining or carrying out the objects of the trust; and part of the income shall be distributed among the Trustees by way of profit, interest, dividends or in any other form; the net income after defraying all expenses in connection with the execution of the Trust and the matters connected therewith be added to corpus of the Trust.

17.5. All properties acquired by the Trust in any manner whatsoever shall be the property of the Trust. None of the Trustees shall use or employ any of the property of the Trust for their personal purposes.

17.6. Any Trustees shall be the custodians of cash and other movable items. The cash, except such amounts as may be necessary for day to day expenses, shall be deposited in the account of the Trust in the Bank.

17.7. Bank Account shall be operated by author of trust.

17.8. All securities and investments shall stand in the name of the Trust.

INVESTMENTS:

All monies available or required to be invested shall be invested by the Trustees, as may think proper in the modes beneficial to the trust.

However, the Trustees are accountable for any action, claim or demand or liability arising against them for anything done by them with intension or motivation, which has got the effect of defeating the objects of the Trust.

20. AMENDMENTS:

The provisions of this deed may be amended by the founder or by the Trustees, in compliance with the requirement of any law or the policy of the Government for the time being in force and such amendments shall not be detrimental to the objects of the trust.

21. IRREVOCABILITY & FAILURE OF TRUST:

This trust formed shall be irrevocable. If for any reason this trust fails or it is resolved either unanimously or by not less than three fourth majority of the Board of Trustees then in office, to dissolve or to wind up this Trust. And the assets so remaining as on the date of dissolution, shall be distributed among the trustees.
